- The EMA owns Eagle Mere Lake and Pond, and a 100 ft. wide reserve surrounding these waters. The EMA is private and its properties are not open to the general public.
- Renters, or guests in a members cottage when the member is not in residence, or guests of the member inns, lodges, B&Bs, must become temporary members of EMA to have access to EMA property and facilities. If you are staying at an Inn, your application and fees will be handled through the Inn.
- On the back of the application, list the names of all adults staying in the cottage during the rental period. A single membership covers the applicants and guests who are staying in the cottage with them.
- Special rates: Rentals for a full calendar month will only be charged for a four week rental.

**Temporary Member Fees:**

| 1 to 10                  | \$170.00 per wk.   | \$180.00 per wk.          | \$195.00 per wk.             |
| 11 to 20                 | \$245.00 per wk.   | \$255.00 per wk.          | \$270.00 per wk.             |
| 21 to 30                 | \$355.00 per wk.   | \$365.00 per wk.          | \$380.00 per wk.             |
| 31 to 40                 | \$460.00 per wk.   | \$470.00 per wk.          | \$485.00 per wk.             |

There is a one week minimum for temporary membership. If you elect not to join initially, and then apply later, you will be required to pay the full amount for the rental period, at the late fee rate. Extra rental days over a weekly period are charged on a pro-rated basis. For example, a cottage with sleeping capacity of 1-10 renting for 16 days, the fee would be \$340 for 2 full weeks, plus \$48.50 (2 extra days prorated at \$24.25 per day) for a total of \$388.50 for the rental period.
